

**RECOMMENDED EXTENSION OF ORDER DENYING MOTION FOR STAY
IN PART AND GRANTING MOTION FOR STAY IN PART**

Appellee moves the Department of Business Regulation to extend DBR Order No. 11-036, attached hereto, because the Show Cause Hearing set-forth in the aforementioned order has been postponed to Wednesday, May 4, 2011 at 1:00PM. The parties came before the undersigned Hearing Officer on April 28, 2011. After consideration of the arguments presented by the Appellee and Appellant, the following order is recommended:

DBR Order No. 11-036 is extended to: (1) grant a stay to the Appellee for the limited purpose of operating under the business format of Lupo's from Thursday, April 28, 2011, through Tuesday, May 2, 2011, during the business hours normally operated by the Appellee; and (2) deny the stay in all other aspects and prohibit the Appellee from acting under any other business format, including, the Roxy. In the event the Show Cause hearing set-forth above is not held on Wednesday, May 4, 2011, the Department expects the parties to return to undersigned Hearing Officer if an extension of this Order is sought.




