PRE-HEARING ORDER

This matter was scheduled for hearing on the Emergency Order Suspending Insurance Producer License, Notice of Hearing and Appointment of Hearing Officer issued by the Director of the Department of Business Regulation (“Director”) on September 14, 2015. The original hearing date assigned by the Director was September 18, 2015, but it was rescheduled to September 21, 2015 at the request of the Respondent.

Respondent did not appear for hearing on September 21, 2015, but counsel (Dawn Oliveri, Esq.) appeared on his behalf. She represented to the Hearing Officer that she appeared at the request of Respondent’s associate attorney, Emili Vaziri, Esq., who will be representing the Respondent. Counsel moved for a continuance of the hearing, based on personal issues of Attorney Vaziri. The Division did not object to the request for continuance, insofar as certain conditions would be placed on the continuance.

Accordingly, the Hearing Officer recommends to the Director that this matter be continued to 2:00 p.m. on October 14, 2015, and that the following conditions be imposed:

1. The suspension of Respondent’s current insurance producer license issued by the Director on September 14, 2015 shall remain in full force and effect.

2. The Respondent is restrained and enjoined from engaging in any and all insurance producer activities or transactions pending further hearing of this matter. This Order shall extend to any associates of the Respondent conducting insurance producing activities on the Respondent's behalf.

3. Attorney Emili Vaziri shall submit a written Entry of Appearance on behalf of the Respondent in this matter (either through electronic mail, hand-delivery or facsimile transmission) before the end of business on September 21, 2015.


