Who is required to renew?

Answer: Any company and branch office whose main office registered in calendar year 2009. To determine what year your company registered please refer to the registration number listed on our “List of Debt Collectors” on our website listed below. The registration number will start with “2009” if your registration was approved in calendar year 2009.

Can’t find the “List of Debt Collectors” on our website?

Follow these instructions:

- 1) Go to www.dbr.ri.gov and scroll down the homepage look for the heading “Banking Regulation” on the right hand side of the home page;
- 2) Click on the heading “Banking Regulation”;
- 3) Next, under “Banking Regulation Links” “PDF files” “List of Debt Collectors”;
- 4) Click on “List of Debt Collectors” heading and
- 5) Search by name of your company.

What is the fee for renewal?

Fee(s): The cost to renew is \$50 training & technology fee plus \$200 per location. Example: Your Company has four (4) offices (one (1) main office and three (3) branch offices). Therefore, the amount due to renew these offices is \$850 (\$200 x 4 plus \$50 training & technology fees).

Due by December 31, 2012
