Auto Body Labor Rate Survey

Insurers and Groups Which Must Participate in 2007 Survey

The following insurers and insurance groups have been determined to meet the criteria in Insurance Regulation 108, i.e. greater than 1% market share, which requires compliance with the regulation in calendar year 2007. The determination of applicability was made based upon 2005 calendar year premium data as reported to the Department through the National Association of Insurance Commissioners.

Pursuant to Insurance Regulation 108, each insurer and insurance group listed below must, prior to February 1, 2007, send questionnaires to the Facilities listed by the Commercial Licensing Division as Fully Licensed Auto Body Repair Facilities. Each insurer and insurance group listed below must file a report with the Department not later than June 1, 2007. Insurers may satisfy the requirements of the regulation by sending questionnaires and submitting the report on a group basis. If the insurance group does not comply with the regulation it is the responsibility of the individual insurers to do so.

Please defer to Insurance Regulation 108 for complete information on compliance. Insurers that are not listed in this bulletin are not required to comply with Insurance Regulation 108 for calendar year 2007 and are not required to send questionnaires or file any report with the Department.
