Emergency Contact and Placard Information Property & Casualty Insurers Non-Compliant Insurers

According to the Department's records, the attached list of insurers have NOT complied with [Insurance Bulletin 2009-4](#) that required all Property and Casualty Insurers (including surplus lines and workers' compensation) to register Emergency Contact and Placard Information with the Department by May 4, 2009 through a portal administered by RI.gov. Insurers included on the attached list must immediately provide the required information. Any insurer that does not register by May 29, 2009 may be subject to administrative penalties and/or revocation of license. This Bulletin does not apply to monoline financial guaranty, mortgage guaranty, title, fidelity and surety, and medical malpractice insurers. If your company is a mono-line carrier, and the company name is on the attached list, please contact paula.palozzi@dbr.state.ri.us for confirmation of exemption.

Please read Bulletin 2009-4 in its entirety. A template form is provided for gathering the necessary information that will be required when logging into the RI.gov website. This information must be readily available **PRIOR** to visiting RI.gov, otherwise the insurer will be unable to complete the transaction. **Do not mail this form to the Department.** Insurers must visit the RI.gov website by **May 29, 2009** to enter Emergency company contact information and Placard Orders. In light of the delinquent reporting, the Department anticipates the delivery of Vehicle Placards on or about June 30, 2009.

Please do not contact the Department to confirm registration. At the end of the submission process, the insurer is provided with a transaction receipt. Please print the receipt and retain it for your records. The attached list reflects insurers that have **NOT** yet registered as of May 15, 2009. Therefore, if your company registered after May 15, 2009 and has a confirmation receipt of transaction, please disregard this Bulletin.
