Auto Body Labor Rate Survey

Insurers and Groups Which Must Participate in 2011 Survey

The following insurers and insurance groups have been determined to meet the criteria in Insurance Regulation 108, i.e. greater than 1% market share, which requires compliance with the regulation in calendar year 2011. The determination was made based upon 2010 calendar year premium data as reported to the Department through the National Association of Insurance Commissioners.

Pursuant to Insurance Regulation 108, each insurer and insurance group listed below must, prior to June 1, 2011, send questionnaires to the Facilities listed by the Commercial Licensing Division as Fully Licensed Auto Body Repair Facilities as posted on the Commercial Licensing – Auto Body portion of the Departments' website at www.dbr.ri.gov Insurers may satisfy the requirements of the regulation by sending questionnaires and submitting the report on a group basis. If the insurance group does not comply with the regulation it is the responsibility of the individual insurers to do so. Please refer to Insurance Regulation 108 for complete information on compliance. Each insurer and insurance group listed below must email a report to Paula.Pallozzi@dbr.ri.gov not later than September 1, 2011. In addition, a hard copy must be mailed to Ms. Pallozzi's attention at the address noted above.
