5-65-3(m) - Failure to secure permits prior to commencing work

Violation Penalty

Description

On October 31, 2021, respondent entered into a Contract to perform Pool repair work at 7 Pond view Drive, Cumberland. This work is of the type which requires that a building permit be taken out prior to commencing work. Upon request, the respondent could not produce the required permit and a check of the Cumberland Town Permitting database showed that no permit had been issued by the Permitting Office.

Violation

5-65-10(a)(10) - Performed work, or arranged to perform work, without a valid registration.

Violation Penalty

1,000

Description

On October 31, 2021, the respondent entered into a Contract to do Pool Repair work at 7 Pond View Drive, Cumberland. This work is of the type which requires registration with the CRLB. A check of the CRLB Registration database showed that the respondent was not registered with the CRLB at the time of the Contract, and remains unregistered with the CRLB at this time.

Violation

5-65-10(a)(12) - Contractor performed improper work

Violation Penalty

1,000

Description

On or about 8/25/2021, respondent performed excavation work around the exterior of the pool skirting, which resulted in the shifting of the pool walls due to not being reinforced/supported/shored up; post excavation of the material. Upon inspection, this work was deemed improper because if the walls had been supported. the damage would not have been an issue, causing further damages to the pool structure.
