Violation

5-65-3(m) - Failure to secure permits prior to commencing work

Violation Penalty

5.000

Description

On or about October 25, 2021, respondent began a project at 7 Fir Dr, Narragansett, which consisted of turning an unfinished attic into livable space. This work is of the type which requires that a building, electrical, plumbing and mechanical permits be secured prior to commencing work. On July 11, 2022, I called Narragansett Building Department and was informed that no permit was issued for this project.

Violation

5-65-10(a)(14) - Failure to complete a project(s) for construction or willfully failed to comply with the terms of a contract or written warranty.

Violation Penalty

1.000

Description

On May 15, 2021, the respondent entered into contract with a resident of 7 Fir Dr, Narragansett, to turn an unfinished attic into livable space. The contract provided indicated work was to start late June or early July. According to the resident of this address, the work began on October 25, 221. On June 14, 2022, the resident filed a complaint indicating that the project was still not finished. Upon inspection of the work performed, I determined that there were walls not finished and the bathroom only had drywall hung, some electrical work and the base of the shower installed, the rest was incomplete. Also, the respondent installed a window and failed to complete the exterior wrap and waterproof it.

Violation

5-65-3(I)(ii) - Use of the word "License" in any advertising when only registered (Statutory \$100.00)

Violation Penalty

100

Description

On or about May 15, 2021, the respondent provided to the customer a contract. On the contract, the respondent listed "License number 42536", when he only has a registration.

Violation

5-65-18 - Failure to provide mechanic's lien notice

Violation Penalty

1,000

Description

Contracts for work require notice that the contractor provide the consumer with a notice that the contractor may file a lien in accordance with the Mechanic' Lien Law, as found in R.I. Gen. Law 34-28. Upon review of the written contract, the required notice was absent from the contract.

Fine amount: \$7,100

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
