

ORDER OF DISMISSAL

The above-entitled matter came for a pre-hearing conference on January 8, 2015 pursuant to the Department of Business Regulation's ("Department") Order to Show Cause Why Cease and Desist Order Should Not Issue, Notice of Hearing and Appointment of Hearing Officer issued by the Department on December 11, 2014 to Diniosio Cabrera ("Respondent"). At the pre-hearing conference, the parties agreed that a temporary cease and desist order be entered against the Respondent so that the Respondent would not be acting as an unlicensed salvage yard in violation of R.I. Gen. Laws § 42-14.2-3. Subsequent therein, the parties worked to resolve this issue and on February 25, 2016, the Department notified the undersigned that the Respondent was in statutory compliance and that this matter could be dismissed. Therefore, on the basis of the above, the undersigned recommends that the temporary cease and desist order be vacated and this matter be dismissed.



LAWS § 42-35-15, THIS ORDER MAY BE APPEALED TO THE SUPERIOR COURT SITTING IN AND FOR THE COUNTY OF PROVIDENCE WITHIN THIRTY (30) DAYS OF THE MAILING DATE OF THIS DECISION.
